

# Letter from the President of the Board of Trustees

#### Dear Friends of Building Families for Children,

As we prepare our annual report, it allows us to reflect on the work and service Building Families for Children has experienced and provided over the past year. The year 2023 can best be described as a year of change, challenge, and blessings. Building Families for Children was blessed to bring Mrs. Tricia Sakles on as Executive Director. Mrs. Sakles has been with BFC for more than 20 years, holding numerous leadership positions, and demonstrating an in-depth knowledge of the organization. The Board of Trustees unanimously approved and welcomed Mrs. Sakles as Executive Director to lead the organization. Another big change that occurred was an agency move to a new location in Columbia that offers considerable savings to the organization, allowing the agency to be better stewards of the resources that God provides through you. BFC has had numerous challenges due to the economy and difficulty with staffing. However, God is Great! According to God's timing, BFC has received grants, donations, and other opportunities, such as the agency move, all of which provided the resources needed to continue to serve many of Maryland's most vulnerable children. As I said, God is Great!

Once again, we would like to thank each of you for your continued support through prayer, time, and financial gifts. BFC remains positioned to continue to serve as a house to share the Good News for the families and children we serve. As Matthew 18:20 says, "For where two or three are gathered in My name, I am there among them." Matthew 7:24-25 discusses the importance of Christ being our footers and firm foundation. "Everyone then who hears these words of mine and does them will be like a wise man who built his house on the rock. And the rain fell, and the floods came, and the winds blew and beat on that house, but it did not fall, because it had been founded on the rock."

While BFC provides a safe, nurturing, and therapeutic environment for healing and reconciliation, it serves a greater role because our families receive the message of Christ. This is due to your continued commitment and partnership. # **Agency Overview & New Mission, Vision, Values**

Building Families for Children is a faith-based nonprofit with a mission to "help Maryland's most vulnerable children and their families thrive by providing trauma-focused supportive services with Christ-like love and compassion."

We believe that every child deserves to grow up in a safe, supportive family. Since our founding in 1920, we've continued to provide services that make that a reality for many children in Maryland! We currently provide trauma-informed care through three programs: CHOSEN Treatment Foster Care, Safe Families for Children®, and Therapeutic Family Services.

During our Strategic Planning process in FY23, our staff and board of trustees refined our Mission, Vision, and Values. While our scope of work remains the same, our updated Mission, Vision, and Values more accurately reflect our foundation of faith and how that guides the work we do.



# **About CHOSEN**

## **CHOSEN At a Glance**

Youth Served: 34

**Youth Achieved Permanency Goals:** 6 (4 moved to independent living situation)

Parents (with placements) reporting satisfaction with the difference they are making in the lives of the youth they have served: 100%

Parents reporting a decrease in negative behaviors stemming from childhood trauma since placement: 63%

We saw an increase in stability this year as evidenced by a 58% reduction in critical incidents!



Through our Children of Special and Exceptional Need (CHOSEN) program, we provide family-based care for children in treatment foster care who, due to childhood trauma, require more than the basic care and support that regular foster care provides. We train foster parents to understand how trauma affects development and equip them with tools and support so the children who are the most likely to be placed in an institutional setting are able to grow and thrive in a family!

Studies show that many youth in foster care have poor long-term outcomes when compared with peers. They are more likely to drop out of school, become teen parents, and experience homelessness.

So what can be done to help our most vulnerable children? Our treatment model, extensive training and support for foster parents, advocacy for permanency, and preparation for independence are breaking the generational cycles of trauma, poverty, and isolation.

Trust-Based Relational Intervention® (TBRI) is the attachment-based, trauma-informed intervention we use to meet the complex needs of vulnerable children. While TBRI is based on years of attachment, sensory processing, and neuroscience research, the heartbeat of TBRI is connection.

# **Impact Story: CHOSEN Treatment Foster Care**

Lucy was just four years old when she entered our CHOSEN Treatment Foster Care program in March 2022. Lucy is diagnosed with Autism Spectrum Disorder and struggles with sensory issues, social interactions, emotional regulation, and fine motor coordination. A lot of teamwork went into getting Lucy the support she needed to thrive. BFC treatment social workers, Lucy's foster parents, various therapists, and Safe Families for Children® volunteers worked together to ensure Lucy received the services she needed to thrive. During the year-and-a-half she was in foster care, Lucy made so much progress!


When we first met Lucy, the only foods she would eat were chicken nuggets and fries because of her sensory issues and difficulties with textures. Lucy was enrolled in a regular feeding clinic that she attended with her foster dad, Brian. Brian learned cognitive reinforcement strategies to keep Lucy focused and modeled desired behavior for her during the clinic and at home. They practiced mealtime routines, including giving her plenty of warning with countdowns before meals. Through the meal clinic and her supportive foster home environment with Brad and his wife Amy, Lucy became comfortable with eating over 40 additional foods! Over time, Lucy expanded her palate to include new favorite foods like chicken wings, broccoli, and cheese.

Lucy also attended the Achievements Therapeutic Day Program through the Kennedy Krieger Institute. Through that program, Lucy learned and practiced emotional regulation and using her words to communicate her needs. Lucy also had opportunities to learn appropriate social interaction and even form friendships within her small group. She also worked with an Occupational Therapist twice a week to help strengthen her fine motor skills. Through Occupational Therapy, Lucy learned how to hold a pencil and paintbrush and use them to draw and color. Brad and Amy also enrolled Lucy in swimming lessons and took her to church. Because of her progress in the various therapeutic support programs, Lucy transitioned from only going to school for half a day to attending the entire day. That was a big deal for Lucy; she loved her teachers and enjoyed going to school.

Lucy's story is a testament to the power of love, support, and dedication. The support Lucy received extended beyond just therapy. Lucy's biological mom, Kelly, was engaged with many of Lucy's therapeutic interventions, including attending family therapy together. During family therapy and regular visits, Kelly and Lucy practiced skills to rebuild connection and ensure a smooth transition back home. Kelly also worked with a support team of her own. A group of approved volunteers from our Safe Families program formed a Circle of Support around Kelly to ensure she had an extended family-like network to rely on when she needed help. The Safe Families volunteers helped Kelly transfer many of Lucy's services to their home county so that Lucy could continue making progress outside of foster care.

Lucy was reunified with Kelly in November 2023, and we are happy to share that they are both doing great!

When crisis strikes, many of us rely on relatives and friends for support. For some parents, this is not an option, which leaves them vulnerable. Safe Families for Children® (SFFC) mobilizes a network of compassionate volunteers to circle around families in need. Host Family volunteers provide a safe, temporary home for children. This allows parents to focus on crisis situations, like homelessness, without worrying about losing parental custody. Family Friend and Family Coach volunteers provide an extra layer of support for both the Host Family and the parents receiving help. This Circle of Support provides the safety net many vulnerable families need to keep children out of the foster care system. Relationships formed through SFFC are long-term, so parents have someone to call if a crisis strikes again.


## The key components of SFFC are:

**Parents** facing crisis situations voluntarily place children in our care.

**Volunteers** form a Circle of Support around families in need. Some host children while others help parents achieve stability.

**Churches** recruit and support volunteers, as well as refer families in need.

Community Partners provide additional services needed to help families achieve long-term stability.


# Impact Story: Safe Families for Children®

In the spring of 2023, the Safe Families for Children® team received a referral from the Department of Social Services for Angela, a single mother with four young children facing housing insecurity. With no family support network, and struggling to provide for her children, Angela feared she would be forced to surrender the children to DSS, where they would enter the foster care system. Angela shared with her Safe Families Family Support Coordinator, Tara, that she felt defeated. Tara saw past the hopelessness and recognized that Angela had a tenacious spirit and a strong will to succeed.

During the three months that Angela's family was being helped, the Safe Families team put out a call to our approved volunteers. Five different volunteer families wrapped around Angela and her children to provide help and support. While the children were hosted and cared for by one of the volunteer families, Angela was able to focus on work and saving enough funds to provide for her family. She was also able to secure stable housing! Safe Families volunteers donated beds for the children, ensured the family had all the necessary home essentials, and helped move everything into Angela's new home—including her children!

Through this Circle of Support, a hallmark of the Safe Families for Children® program, Angela now has an extended family-like support system. Host families provide child care and respite for the children. Angela also has people she can rely on for emotional support and encouragement. One family recently accompanied Angela to a custody hearing so she wouldn't have to face it alone.

Nine months ago, Angela saw no alternative but to give up her children. Today, she has a home, and is finishing her first semester at Morgan State University! She has a support system of people who love her and her children unconditionally. Angela's experience with the loving and supportive community in Safe Families for Children® has reinvigorated her spirit. Her confidence has grown. Angela is empowered to make the best choices for her family, and is looking forward to all the possibilities awaiting them!

Our therapists work with children of all ages and their caregivers to address emotional and behavioral difficulties resulting from trauma. We help families of all types (adoptive, foster, and biological) to connect, heal, and thrive together!

Childhood trauma makes a lasting impact on the brain, hindering a child's ability to learn, grow, and form healthy attachments with others. Our therapists' approach is based on the principles of Trust-Based Relational Intervention® (TBRI), a holistic, attachment-based, trauma-informed intervention designed to meet the complex needs of vulnerable children. Our therapists may also integrate other interventions and tools into treatment to best serve each client. In addition to TBRI, some of the other modalities our therapists use in treatment are:

#### Mindfulness

**Theraplay** 

**Cognitive Behavioral Therapy** 

**Eye Movement Desensitization and Reprocessing (EMDR)** 

**Emotional Freedom Technique (EFT)** 

Caregivers are actively engaged in each therapy session. Both caregivers and children learn the TBRI principles and skills so they can use them at home and enjoy lasting, positive change in their relationships.





#### Qualities & Characteristics of our Board Members


BFC seeks board members who are passionate about the organization's mission, vision and values, reflect the demographics and/or represent the interests of the community BFC serves, and meet the following criteria:
