Each year brings new challenges, and 2024 was no exception. Finding qualified and committed staff, recruiting loving and supportive foster families to meet the growing needs of foster youth, and helping families navigate increasingly complex life circumstances have all become more difficult. At times, the weight of these challenges can feel overwhelming, and we need to be reminded of the calling that brought us here. We know that when we stay focused on our mission—to help Maryland's most vulnerable children and their families thrive by providing trauma-focused supportive services with Christ-like love and compassion—God will guide us through. That was our foundation in 2024, and it will continue to sustain us in 2025.

Recently, a 14-year-old boy in our Safe Families for Children[®] program reminded us of what truly matters. We currently provide trauma-informed care through three programs: CHOSEN Treatment Foster Care, Safe Families for Children[®], and Therapeutic Family Services.

To help Maryland's most vulnerable children and their families thrive by providing trauma-focused supportive services with Christ-like love and compassion.



CHOSEN TREATMENT FOSTER CARE



About CHOSEN

CHOSEN At a Glance

Youth Served: 32

Youth Achieved Permanency Goals: 10; 83% of youth who left the program went to more permanent living situations. (6 reunifications, 3 adoptions, 1 move to an Independent Living Program.)

Parents (with placements) reporting satisfaction with the difference they are making in the lives of the youth they have served: 100%

Youth surveyed who reported that their life is moving in a positive direction: 90%

We saw an increase in stability this year as evidenced by a 60% reduction in critical incidents!



Through our Children of Special and Exceptional Need (CHOSEN) program, we provide family-based care for children in treatment foster care who, due to childhood trauma, require more than the basic care and support that regular foster care provides. We train foster parents to understand how trauma affects development and equip them with tools and support so the children who are the most likely to be placed in an institutional setting are able to grow and thrive in a family!

Studies show that many youth in foster care have poor long-term outcomes when compared with peers. They are more likely to drop out of school, become teen parents, and experience homelessness.

So what can be done to help our most vulnerable children? Our treatment model, extensive training and support for foster parents, advocacy for permanency, and preparation for independence are breaking the generational cycles of trauma, poverty, and isolation.

Trust-Based Relational Intervention[®] (TBRI) is the attachment-based, trauma-informed intervention we use to meet the complex needs of vulnerable children. While TBRI is based on years of attachment, sensory processing, and neuroscience research, the heartbeat of TBRI is connection.

Impact Story: CHOSEN Treatment Foster Care

In January 2024, Cathy welcomed her first foster placement—a spirited 16-year-old named Emmie. Having completed her CHOSEN certification just months earlier, Cathy was eager to put her Trust-Based Relational Intervention[®] (TBRI[®]) training into practice. She understood that fostering a teenager meant walking a delicate line between guidance and independence, and she was ready for the challenge.

Before coming into Cathy's care, Emmie faced significant difficulties at home that affected her academic progress. The transition to a more supportive school environment offered a fresh start, but Emmie needed more than just a new classroom—she needed stability, patience, and trust.

Cathy embraced TBRI[®] principles from day one, creating a space where Emmie felt safe to grow. Knowing that Emmie had a history of reacting impulsively, Cathy introduced mindfulness techniques and the concept of redos. When Emmie would react, rather than respond, Cathy encouraged Emmie to reflect on her choices and consider alternative responses. Over time, these small but powerful moments helped Emmie develop emotional resilience and accountability.

Cathy and Emmie bonded in the kitchen, working as a team to prepare meals—an activity that encouraged both cooperation and conversation. They also started a tradition of monthly dates together, setting aside time for just the two of them. As the connection between Emmie and Cathy grew, Emmie opened up about her past traumas, finding reassurance and validation from Cathy and her BFC social worker, Brianna.

Like any teenager, Emmie grappled with the push-and-pull of independence and authority. She was candid about wanting to spend time with her boyfriend, and Cathy recognized the importance of balancing structure with freedom. Wanting Emmie to feel supported in her relationships, Cathy took the initiative to include Emmie's boyfriend and his family in their Christmas celebration this year. This thoughtful gesture reinforced that Emmie's connections mattered and that she was part of a home where she was valued and accepted.

With Cathy's support, Emmie has grown in confidence and resilience, embracing a future full of possibilities. She envisions completing high school, transitioning into independent living, and pursuing a career working with animals. Cathy and Emmie's journey is a testament to the life-changing impact CHOSEN foster parents can have. Through patience, understanding, and trust, they have built a foundation for lasting transformation that will guide Emmie well beyond her time in foster care.



When crisis strikes, many of us rely on relatives and friends for support. For some parents, this is not an option, which leaves them vulnerable. Safe Families for Children[®] (SFFC[®]) mobilizes a network of compassionate volunteers to circle around families in need. Host Family volunteers provide a safe, temporary home for children. This allows parents to focus on crisis situations, like homelessness, without worrying about losing parental custody. Family Friend and Family Coach volunteers provide an extra layer of support for both the Host Family and the parents receiving help. This Circle of Support provides the safety net many vulnerable families need to keep children out of the foster care system. Relationships formed through SFFC are long-term, so parents have someone to call if a crisis strikes again.

The key components of SFFC are:

Parents facing crisis situations voluntarily place children in our care.

Volunteers form a Circle of Support around families in need. Some host children while others help parents achieve stability.

Churches recruit and support volunteers, as well as refer families in need.

Community Partners provide additional services needed to help families achieve long-term stability.

Impact Story: Safe Families for Children®

When Amani arrived in the United States seeking asylum, she was pregnant with twins. She felt isolated and alone. Her husband and young son remained in her home country. She was unhoused with no source of income and no support network.

Amani connected with the Safe Families for Children[®] at BFC just before her twins were born. A Safe Families[®] Host Family welcomed her into their home and provided a safe place where she could rest and prepare for motherhood. A local Safe Families[®] partner church rallied around her in ways Amani never expected. Volunteers gathered essential baby supplies and covered the cost of an immigration attorney so she could begin the asylum process.

When her initial host family arrangement ended, another family stepped in for six weeks. They provided a stable place for her to call home as Amani worked to secure long-term housing. As her Safe Families[®] community continued to grow, they celebrated every milestone. Safe Families[®] staff hosted a party for her twins' first birthday, which brought together friends and volunteers from three different Safe Families[®] partner churches!

In December 2023, Amani received her work permit—what she calls her best Christmas present ever. Soon after, she accepted a position as a receptionist at a small business. With respite support from Safe Families® volunteers and childcare vouchers for her twins, she took steady steps toward independence. Her church small group helped her purchase a car, and donations to BFC funded the first six months of her auto insurance.

In July, Amani and her twins moved into a townhouse. It was the first home she could call her own since arriving in the United States! As her natural support network grew, Amani's time with Safe Families for Children[®] came to a close. Though she graduated from the program, the relationships she built remained strong.


Today, Amani is not only thriving but also giving back. She is using her experience to advocate for families in crisis and turning her challenges into a source of hope for others.

TFS At a Glance

Families Served: 9

Our therapists work with children of all ages and their caregivers to address emotional and behavioral difficulties resulting from trauma. We help families of all types (adoptive, foster, and biological) to connect, heal, and thrive together!

Childhood trauma makes a lasting impact on the brain, hindering a child's ability to learn, grow, and form healthy attachments with others. Our therapists' approach is based on the principles of Trust-Based Relational Intervention[®] (TBRI), a holistic, attachment-based, trauma-informed intervention designed to meet the complex needs of vulnerable children. Our therapists may also integrate other interventions and tools into treatment to best serve each client. In addition to TBRI, some of the other modalities our therapists use in treatment are:

Mindfulness

Theraplay

Cognitive Behavioral Therapy

Eye Movement Desensitization and Reprocessing (EMDR)

Emotional Freedom Technique (EFT)

Caregivers are actively engaged in each therapy session. Both caregivers and children learn the TBRI principles and skills so they can use them at home and enjoy lasting, positive change in their relationships.




